

Missouri Governor Bob Holden signed a bill on June 13, 2002 authorizing the use of the official emblem of The Hearing Improvement Kids Endowment Fund, Inc. on personalized HIKE License plates for your car and other vehicles. This is an excellent promotion for Job's Daughters as well as The HIKE Fund.



**To get a HIKE LICENSE PLATE follow these steps:**

1. Complete this form and send it to the HIKE License Plate Liaison at the address below together with your contribution to The HIKE Fund, Inc. of \$25 for one year or \$50 for two years.
2. You will be sent two documents: "Emblem Use Authorization Statement" and an "Application for Missouri Personalized and Special License Plates" DOR Form 1716.
3. Complete the "Application for Missouri Personalized and Special License Plates." Select up to a six character personalized plate message. (Four characters for a disabled plate). All HIKE license plates are considered personalized plates and require payment of a \$15 one-year personalized fee, or \$30 two-year fee to the Department of Revenue.
4. Take your "Application for Missouri Personalized and Special License Plates," "Emblem Use Authorization Statement " and the \$15 personalized a plate fee (\$30 if two-year) to your local license office OR send to Motor Vehicle Bureau, P.O. Box 100 , Jefferson City MO 65105-0100.
5. The Department of Revenue will order your plates. You will be notified when your plates are available and given information about getting them at your local license bureau. If you have any questions about processing, or your "Application for Missouri Personalized and Special License Plates," direct them to the Department of Revenue through your local license bureau.

**When can you order the HIKE LICENSE PLATE?** You can order HIKE license plates at any time regardless of your current license plate expiration date. Hike plates expire annually, or biannually, in the month in which they were first purchased. Yearly renewal requires a minimum \$25 donation to the HIKE Fund, Inc.; biennial requires a minimum \$50 donation. To obtain a current "Emblem Use Authorization Statement" make your donation before you renew your plates. When renewing, remember to take your current "Emblem Use Authorization Statement, signed in the necessary manner and other paperwork needed by the DMV with you.
