While work is in progress, the Mother Mick Memorial Room and historical display will be closed.

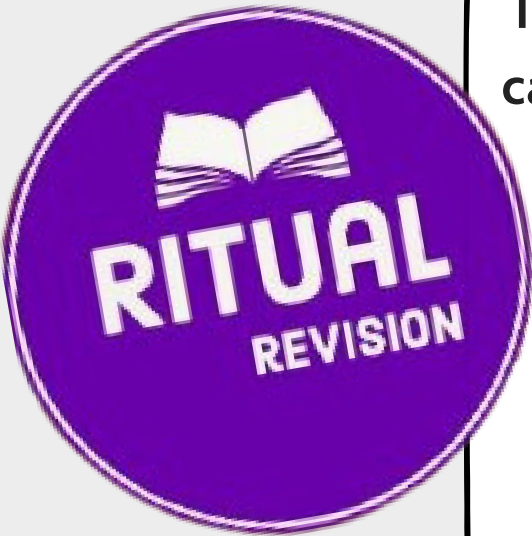

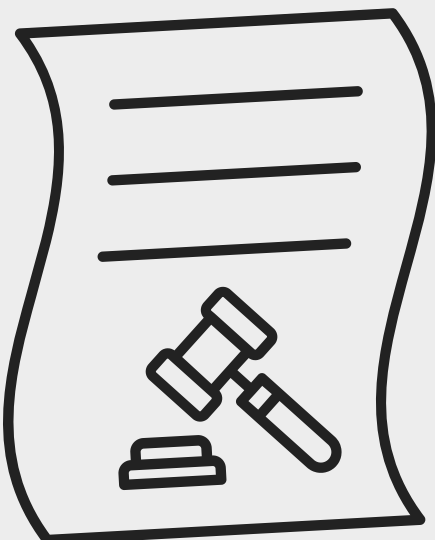

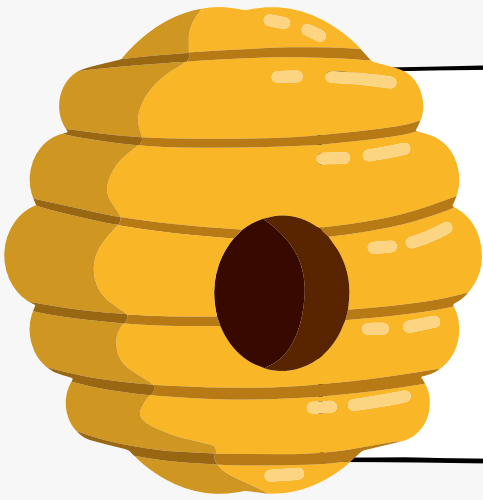
