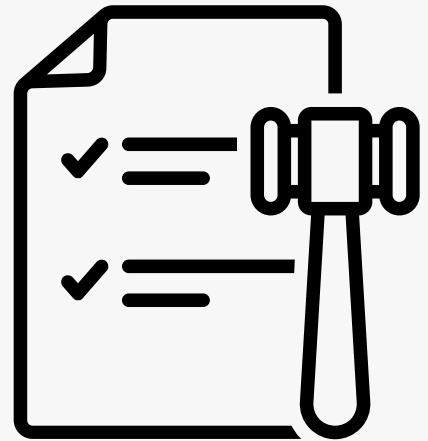

The form includes information about obtaining a special event rider policy. It is also an electronic form, so you will no longer need to download a copy and submit it to the Supreme Office via email - the system will do that for you!

Submission does not necessarily equal approval (subject to underwriting). Each Bethel, JGC, GGC may be billed-back for premiums (rate expected be lower than market for most events).
