All proposed amendments to the Constitution, Bylaws and Standard Operating Procedures of Missouri **MUST** be submitted in triplicate with required wet signature(s) of proposer(s) (voting delegates of the Grand Guardian Council) to Kim Underwood on behalf of the Jurisprudence Committee and one copy with signature(s) to the Grand Secretary ON OR BEFORE April 1, 2024. An amendment form is attached for your convenience.

Exact explanation is in the MO-SOP-SGC-16 - Rules of Order and Parliamentary Authority.

*MO-3. AMENDMENTS – Amendments to these Constitutions or Bylaws may be made at the Annual Session by a two-thirds (2/3) affirmative vote of the members present and voting. Amendments to Standard Operating Procedures shall be made at the Annual Session by a majority affirmative vote of the members present and voting. **Providing such amendments have been submitted in triplicate to the Jurisprudence Committee and one copy to the Grand Secretary on or before April 1<sup>st</sup>.***

*MO-5. **Proposed amendments shall be signed by a bona fide member of this Grand Guardian Council and submitted in a form so as to show the Article, Section and the wording of the entire paragraph as amended.** Amendments which propose only to delete, insert or substitute figures, letters, words, phrases or sentences will not be accepted by the Jurisprudence Committee or the Grand Secretary.*
