We are looking for Daughters ages 16-19 who are interested in participating this year in Glendale, Arizona during the business meetings of the Supreme Guardian Council. This unique experience allows you to be in the room, hearing the discussions, and voting on things that have a significant impact on you as an active member of our Order. This is an exciting opportunity, so please read the following information carefully before filling out your application.

In this packet you will find: Supreme Bylaws on Voting Members, Missouri requirements and expectations, and THREE Applications to be sent back to me by April 1st, 2025. Please get the applications to your Bethel and Parents/Guardians early enough so you don't miss the deadline!

Supreme Guardian Council Bylaws:

Bylaws SGC - ARTICLE XV — ELECTION, VOTING PRIVILEGES, AND PROXY Section 2. Voting Privileges

- (c) Additional Voting Members: (See POL-BOT-5)
 - 1) Each Jurisdiction shall select two (2) active Daughters to be voting delegates at Supreme Session. Selection process will be determined by the Jurisdiction.
 - 2) The selected active Daughters shall be registered voting delegates per registration of the Annual Session 2022 Bylaws SGC B-SGC 15
 - 3) The active Daughters will be allowed to speak as voting delegates in conformity with the laws of the SGC and Robert's Rules of Order Revised (latest edition)
 - 4) Names of Daughter Voting Delegates shall be forwarded to the Executive Manager by the Grand Secretary, Jurisdictional Secretary, and Supreme Deputies of all other Jurisdictions no later than May 31 prior to the Annual Session of the SGC.
- (d) Each voting delegate shall be entitled to only one (1) vote

Missouri Delegation Requirements:

- Attend Supreme Session 2025 in Glendale, Arizona, the entire Session (July 22-26, 2025).
- Be 16-19 years of age at the time of Supreme Session.
- Be an Active Member of your Bethel and Grand Bethel.
- Have a general understanding of JDI Bylaws and interpretation.
- Attend all meetings of the SGC to vote during Supreme Session.

Note: These will conflict at times with other fun activities scheduled or member events at Supreme Session. It is not recommended that anyone apply to be a delegate if they are aspiring to SBHQ and/or MIJD at the same Supreme Session. There will be overlap between events you would need to attend for those positions with the meetings. If you truly wish to apply while also aspiring to either SBHQ and/or MIJD, please discuss your interest with the GG and VGG before applying.

Things of note for the two chosen Daughter delegates:

- The In-Person Voting Daughter Delegate Registration Fee (\$125) will be reimbursed by the GGC following Supreme Session, however, the balance of the cost for Supreme Session is your responsibility. Please note that if there are any increased registration fees after the May 19th date, they will not be considered for reimbursement.
- You will be expected to attend all meetings of the SGC at Supreme Session to vote.
- Your vote counts!!! Be looking over the presented amendments when they are released talk to your fellow Members to understand how they feel about the amendments.
- There will be a fair number of Missouri delegates (Adults) at the SGC Meetings as well. Use them as a resource to help with any questions you may have prior to, or during, the meetings to help you understand the changes. We have all been to the meeting for the first time and realize it can get confusing and overwhelming.
